Requirements: • Valid company Tax Clearance Certificate must be attached • Certified copy of the company registration certificate/founding certificate must be attached • Copy of company profile with clear and traceable references especially with Municipalities • Valid B-BBEE verification certificate must be attached • CSD registration report/support number • Certified copy of any registration with relevant authorities must be attached • Service provider must be accredited by the South African National Accreditation System (SANAS) • Service providers must collect samples from FDDM with equipped transport having specialised equipment and correct procedures to be followed. Present FDDM with sample data analyses within 5 days • There might be compulsory presentations to short-listed companies at Fezile Dabi District Municipality Offices, John Voster Road, Sasolburg (opposite Penny Heyns Swimming Pool) • Municipal rates & taxes information in the bid document must be duly completed by your Local Municipality or your Landlord • All compulsory/supplementary forms must be fully completed and signed (that is MBD 1, 4, 6, 8 and 9).

NB: Companies within a radius not exceeding 150km from Fezile Dabi District Head Office in Sasolburg that completely qualify will have an added advantage to be invited for presentations and to be further evaluated.
